This certifies that _____ (mare owner) agrees to breed the mare _____ Reg.# _____ Breed _____ to **Cooltest Sensation** for the 20____ breeding season.

It is hereby understood and agreed that:

1. The Breeding fee is \$1,0000 which is due before the semen is shipped. The nonrefundable booking fee of \$250.00 is payable upon execution of this contract. Consideration given to proven mares or multiple bookings.
2. A photo copy of both sides of the mare's Registration papers, with current owner listed must accompany this contract.
3. -M Quarter Horses will begin shipping cooled semen on or about March 1st. On site mares will be the breeding priority however every attempt will be made to ship semen on the requested day. The first shipment is included in the breeding fee. There will be a \$250.00 charge plus shipping fee for each subsequent shipment. A limit of 3 shipments will be sent per breeding year. Frozen semen is available for shipping at any time; however, shipping fees are determined by the storage facility and payable to them.
4. -M Quarter Horses agrees to ship cooled transported semen as directed above. Requests for semen must be made at least 24 hours prior to shipping time. Cancellation must be made by 8:00 AM shipping day. Insemination must be done by a qualified person, under strict supervision of a Veterinarian. -M shall be held blameless if mare fails to settle.
5. A shipping container will be provided by -M Quarter Horses. Containers will be returned to the -M in a timely manner. Should the mare owner fail to return the container, they will be billed for the cost of the container.
6. It is agreed that should the above named stallion die or become unfit for service, this contract may be fulfilled with frozen semen, if available at the time. If the mare dies, the mare owner may substitute another mare to be bred.
7. -M Quarter Horses offers the mare owner a live foal guarantee. A live foal is described as a newborn foal that stands and nurses. If the mare fails to produce a live foal, the mare owner is entitled to a return breeding the following year with a charge of \$250.00 fee for collection, packaging plus shipping of cooled semen. Stallion fees are non-refundable.
8. If the mare is checked in foal and later aborts or fails to produce a live foal it is the responsibility of the mare owner to notify - M Quarter Horses in a timely manner. Live foal guarantees are only valid for the following breeding season.
9. If the mare is checked in foal but dies before foaling and this is reported to -M Quarter Horses within 48 hours, and substantiated within 15 days by a licensed veterinarian the mare owner will be given a rebreed to another mare the following breeding season subject to the fees described in paragraph (7).
10. This contract is not transferable or assignable. There shall be no right of return to the stallion if the mare named in this contract is sold or otherwise changes ownership after being bred to the stallion named in this contract except at the

discretion of -M Quarter Horses.

11. A Breeders Certificate will be issued only after the mare owner has notified -M Quarter Horses that the mare has produced a live foal and bills have been paid in full. Owner recorded on the Registration Certificate will be recorded on the Stallion Breeding Report.

12. This contract shall be construed and governed by the laws of the State of Montana, and shall be binding upon the parties represented in this contract.
